we were thrilled when, after four years of submitting testimony, this bill finally passed.

March saw the cancellation of many events such as the 2020 Maryland Women's Hall of Fame and Women of Tomorrow Induction Ceremony (we had served on the selection committees) due to COVID-19 concerns. Although we had already begun planning for our Annual Conference to be held in May, once the Governor proclaimed a health emergency and then issued orders prohibiting large gatherings and closing non-essential businesses, we had to reassess our plans.

As it became clear that the health crisis is not going to be resolved anytime soon, we decided to cancel our face-toface meetings scheduled for the rest of this year and to hold a virtual annual conference on September 12. shley Oleson is State Director for the League of Women Voters of Maryland. The League is a nonpartisan issue-based political advocacy group, which works to educate and empower voters and promote and protect democracy.

Ashley's primary policy work in Maryland has centered on redistricting reform. In 2015, she was appointed to serve on Maryland's Redistricting Reform Study Commission and in

How Race and Gender Matter in Elections

anice Mathis was appointed as the Executive Director of the National Council of Negro Women (NCNW) in 2016. NCNW was founded in 1935 by Dr. Mary McLeod Bethune and is an affiliation of 32 national women's organizations and 200 campus and community-based sections, reaching a membership of more than two million. As Executive Director, Janice is responsible for all programming, grassroots lobbying, communications, fund development, and member recruitment and retention.

With a wealth of experience as a lawyer, negotiator, advocate, administrator and team builder, Janice has served as Special Assistant Attorney for the State of Georgia; testified before the United Nations Commission to End Racial Dis-

crimination in Geneva; and organized and led a national effort to reauthorize the Voting Rights Act in 2005. She serves on Delta Sigma Theta Sorority's national Social Action Commission, where she is responsible for tracking the sorority's legislative agenda. She helped to found Power Rising, now in its third year. She formerly served as a member of the Rules Committee of the Democratic National Committee and on the national board of the League of Women Voters of the U.S.



Janice is the recipient of many awards. In 2008, the *Georgia Informer* named her one of the 50 most influential women in Georgia. She earned Bachelor of Arts degrees in both economics and public policy studies at Duke University; studied British Politics and History at Oxford University in England; and earned a Juris Doctor degree from the Lumpkin School of Law at the University of Georgia, Athens.

We are honored to have Janice Mathis as our keynote speaker. As a result of a lifetime of activism, Janice has reached certain conclusions about the way that race and gender tend to play out in U.S. elections. Based on her experiences, we expect to hear how women have been represented in campaigns and as public office holders.

Although the number of women serving in elected office has risen slowly in the century since women won the right to vote in 1920, we know that throughout history in both the feminist and civil rights movements, women of color have been pushed out. Do sexism and racism still hold women back in seeking office, and what strategies are successful in helping women achieve electoral success? What more can Black and White women do to propel the nation forward? Join us in a conversation about race and gender in politics.

BPWF/MD Scholarships




The Business and Professional Women's Foundation of Maryland has awarded two scholarships for the academic year 2020-2021.

The Colors of Women's Suffrage

Since we are celebrating the 100th Anniversary of Women's Suffrage at our 2020 Annual Conference, we thought it would be fun to wear the colors of the women's suffrage movement as a tribute to the hard-fought campaign waged by American women for the right to vote. But what are these colors and their significance?

White stood for the purity and symbolism of our purpose. **Purple** stood for the color of loyalty, constancy to purpose, unswerving steadfastness to the cause. In the United States, **gold** replaced the green of our British counterparts. **Gold** stood for the color of light and life of the torch that led us. The three tricolors signified loyalty, purity and life.

An interesting fact was how gold was placed into our American three colors rather than keeping the British green. It happened in 1867, when Kansas was considering the passage of a state suffrage referendum. Elizabeth Cady Stanton and Susan B. Anthony adopted the Kansas state flower, the sunflower, as a symbol of the suffrage cause. Gold pins, ribbons, sashes, as well as yellow roses became symbols of the cause – "VOTES FOR WOMEN."

Throughout history, color has always been a way to provide instant recognition. Our three colors – **white**, **purple** and **gold** – are the colors of Women's Suffrage. So, as we plan our hopeful list of clothes for our conference, see what you might have in your closet. If you are not planning on attending, write these colors on your calendar for September 12 and wear them wherever you are. Our BPW sisterhood could not be stronger than in the challenging times confronting us now. See you on the ZOOM Conference.

Celebrate the 100th Anniversary of Women's Right To Vote!

ugust 26, 2020 marks the 100th anniversary of the ratification of the 19th Amendment, granting women the right to vote. Throughout 2020 and into 2021, Americans will celebrate the centennial of women's right to vote. When Congress passed the 19th Amendment in 1919, and 36 states ratified it by August 1920, women's right to vote was enshrined in the U.S. Constitution.

Having been a member of BPW since 1972 (48 years!) and celebrating Women's History Month and learning about women in history each year for all those years, I thought I knew all the important women in history and especially those prominent suffragists who fought so hard to get women the right to vote. However, when I watched the Maryland Public TV's two-night presentation of "The Vote," I found that I was wrong. I learned about two suffragists whom I had not heard of before and I wondered why, based on their importance to the cause. So, I want to "celebrate" them here and introduce them to you, in case you don't know them.

One of the suffragists is Harriot Stanton Blatch, an American writer and suffragist. How could I not have heard of her? Her famous mother, Elizabeth Cady Stanton, was a leading pioneer and activist in women's rights. The other woman is Mary Church Terrell, an African American national activist for civil rights and suffrage.

Harriot Stanton Blatch,

a feminist activist, suffrage strategist, leader in labor reform, writer, and biographer of Elizabeth Cady Stanton, was born in 1856 in Seneca Falls, New York. Her mother, Elizabeth Cady Stanton, was already organizing for women's rights, while her father was active in reform causes, such as anti-slavery. She was educated privately until she was admitted to Vassar College where she received a degree in Mathematics in 1878. She then

attended the Boston School for Oratory, and began to tour with her mother, in America and overseas.

Harriot assisted her mother and Susan B. Anthony in completing their *History of Woman Suffrage*. She contributed a 100-page chapter on Lucy Stone's Woman Suffrage Association, a rival of Stanton's and Anthony's National Woman Suffrage Association.

In 1882, Harriot married William Blatch, an English businessman, and they lived in England for the next 20 years. During that time, she moved in British reform circles, especially that of the Fabian Society, a British socialist organization whose purpose was to advance the principles of democratic socialism via gradualist and reformist efforts in democracies, rather than by revolutionary overthrow.

The Blatch family moved back to the U.S. in 1902, and Harriot became involved in the Women's Trade Union League and the National American Woman Suffrage Association, which she found apathetic and ineffective. So, in 1907, she founded the Equality League of Self-supporting Women, leading the organization to enroll thousands of working women who had never been sought after or attracted to suffrage organizations, thereby injecting new life into the cause.

After her husband died in 1915, Harriot regained her American citizenship she had lost by marrying a foreigner, which she protested bitterly because it only applied to women. She spent 1915-1917 in England, settling her husband's affairs. Upon returning to the U.S., she became head of the speakers bureau of the wartime Food Administration and a director in the Women's Land Army, a civilian organization during the First and Second World Wars to work in agriculture replacing men called up to the military.

After the successful conclusion of the suffrage campaign, Harriot Blatch remained active in women's rights and socialist activities. She worked through the National Women's Party for a federal equal rights amendment.

Her books include *Mobilizing Woman Power* (1918) and *A Woman's Point of View: Some Roads to Peace* (1920). In 1932, she published *Elizabeth Cady Stanton as Revealed in Her Letters, Diary and Reminiscences* with her brother. An accident in 1927 forced Harriot to live in a nursing home. Her autobiography *Challenging Years*, written with Alma Lutz, was published in 1940, the year she died.

In 1896, she was the first African American woman in the United States to be appointed to the school board of a major city, serving in the District of Columbia until 1906. A charter member of the National Association for the Advancement of Colored People and the Colored Women's League of Washington, she helped found the National Association of Colored Women (NACW) and served as its first national president. Her words, "Lifting as We Climb," was the NACW motto. She believed that improving oneself through education, work and community activism would help end racial discrimination. In 1910, she co-founded the College Alumnae Club, later renamed the National Association of University Women.

Considered the best educated black woman of her time, Mary Terrell was well known as a national activist for civil rights and suffrage. She fought for these causes because she believed she belonged to the only group in the country that had two such huge obstacles to surmount...both sex and race. She was part of the rising black middle and upper class and used her position to fight racial discrimination. She also actively campaigned for black women's suffrage because she felt it was essential to elevating the status of black women and the entire race. Following the passage of the 19th Amendment, Terrell focused on broader civil rights. In 1940, she published her autobiography, *A Colored Woman in a White World*, describing her experiences with discrimination. In 1948, Mary Terrell became the first black member of the American Association of University Women, after winning an anti-discrimination lawsuit.

Fighting for the rights of women and black Americans, she played a key role in moving desegregation forward. In 1950, at the age of 86, she started challenging segregation in public places. At the age of 90, she took a case, *District of Columbia v. John R. Thompson Co., Inc.,* to the U.S. Supreme Court and won a unanimous decision that outlawed racial discrimination in D.C.'s eating establishments, ending lunch counter segregation in the nation's capital.

Among her friends, Mary counted noted leaders such as Frederick Douglass, Susan B. Anthony, and Ida B. Wells. Mary Church Terrell died in 1954, in Highland Beach, Md.

BPW/MD ELECTED OFFICERS' DUTIES Bylaws ARTICLE XI

PRESIDENT: The president shall serve as the principal officer of BPW/MD and preside at all meetings of the organization - the board of directors, the executive committee; assure appointments of committee chairmen and non-elective officers: is ex officio member of all committees, except the nominating committee.

PRESIDENT-ELECT: The president-elect shall act as representative of the president; serve as planning chairman to develop and coordinate programs of the ensuing year; select committee chairmen for the following year.

FIRST VICE PRESIDENT: The first vice president shall perform the duties of president in the absence of the president; become the president for the unexpired term in case of death, resignation or incapacity of the president; is administrative coordinator.

SECOND VICE PRESIDENT: The second vice president shall perform the duties of the president in the absence of the president and the first vice president; is program coordinator.

SECRETARY: The secretary shall record and transcribe the proceedings of the Annual Conference, the board of directors and the executive committee meetings; manage the BPW/MD correspondence.

TREASURER: The treasurer shall deposit, immediately, all monies of BPW/MD in a bank account approved by the executive committee; remit to BPW Foundation all money payable thereof; remit all appropriate money to the Local Organizations; file federal and state tax returns; prepare budget, monthly financial reports and treasurer's annual report for audit; is ex officio member of the finance committee.

All Executive Committee members are Directors/ Trustees of the BPW Foundation of Maryland.



Equal Rights dvocacy -Amendment. "Equality of rights under the law shall not be denied or abridged by the United States or any State on account of sex" needs to be placed into our Constitution. While most states have laws prohibiting discrimination of any kind based on sex, proponents of the ERA say laws can be reversed or eliminated. Having a Constitutional Amendment would cement those rights.

Let me start from the beginning since so much happened in the month of June. The National Archivist had recorded the ERA ratifications of Nevada and Illinois, but refused to record Virginia's ratification without a court order. A suit has been brought forth to the Court to order the National Archivist to do his duty and record Virginia, putting the ERA into the Constitution. This ERA case is being brought forth by the three Attorneys General of Nevada, Illinois, and Virginia.

These attorneys general are asking for interested parties to sign on to their suit in the way of an Amicus Brief. This is a legal document filed in appellate court by non-litigants with a strong interest in the subject matter. The briefs advise the court of relevant, additional information or arguments that the court might wish to consider.

An Amicus Brief helps to bolster a case because it shows outside interest and allows for additional arguments. Courts pay attention to Amicus Briefs and can be influenced favorably by the signatures and their arguments. The published list of signers is now over 50 organizations and still rising.

But, our historical news is that the National Federation of Business and Professional Women's Clubs is proud to announce that we filed the appropriate papers and a statement of the mission of our organization. We have been a long and ardent supporter of the passage of the ERA. Checking with the Alice Paul Institute, we were mentioned in Alice's journals as early as 1937. We have continued long and hard in our efforts.

The "short" paragraph that I wrote for us was as follows:

The National Federation of Business and Professional Women's Clubs was organized in 1919. With over 100 years of dedication, our mission has been to develop the business, professional and leadership potential of women on all levels through education, advocacy, networking, mentoring, skill building, economic empowerment programs and projects. We are a memberbased organization with clubs throughout the United States. We have a Virtual Club as well as a Young Business and Professional Women's group. As early as 1937, the National **Federation of Business and Professional Women's Clubs** supported the Equal Rights Amendment, and has continued its support through the decades for its quest to become part of the United States Constitution. We believe in the equal rights of all women and girls.

We, BPW, have collected funds to support the ERA, with the last tabulation at \$250,000.

The paragraph was to be as brief as possible, but sharing our mission and



goals as an organization. The actual Amicus Brief was brought to the Federal Court in Washington, D.C., by the law firm of Winston and Strawn, of Chicago, Illinois. Linda Coberly, Esq. is the individual who is collecting all the materials and doing the filings.

But, two weeks have now passed, and I am searching ever so hard as to what is happening to date. I have learned that a dozen more organizations have been added to the filing of the ERA Amicus Brief. The U.S. Conference of Mayors, representing every city in the United States with over 30,000 residents, will be filing their own Amicus Brief. Lastly, I have discovered that the mega corporations of Apple, Google, PepsiCo., Airbnb, Uber and the NFL are taking positions and standing by the American women and girls with their own brief in support of the ERA.

I have discovered that there are anti-equality forces sharing their arguments and opposition to the ERA. There is still research to be done and I will keep a close eye on these developments, so I can report the latest ERA news at our September conference.

In Memoriam

FLORENCE A. FINLAYSON BPW/MD Past State President, 1984-85 Montgomery County BPW

Jan. 23, 1930 – Dec. 21, 2019

Born in 1930 in Jefferson County, Birmingham, Alabama, **Florence Finlayson** spent her childhood in Alabama, Georgia, and D.C., before settling in Maryland. Her

father was an officer in the military and her mother worked for the United States Coast Guard. She had two brothers. She never married or had children, so she took part in the lives of her brother's four children.

Much of her life was spent in Bethesda, where she graduated from Bethesda Chevy Chase High School. Her first job was as a clerk-typist for the U.S. Maritime Commission in D.C. In 1949, she was "temporarily loaned" to the D.C. Government where she worked for over 30 years. In 1980, as a Senior Supervisory Tax Conferee and a Civil Service employee, Flo retired and went into the private sector.

Starting in BPW as a charter member of Potomac BPW, Flo was an active BPW member from the beginning. After serving as First Vice President and President-Elect, she became Potomac's President for 1978-80. Also active at the state level, she served as BPW/MD President in 1984-85. More recently, Flo served BPW/MD as Bylaws Chair and Parliamentarian. Flo credited the Individual Development Program with helping her to develop her speaking skills and for giving her the courage to run for office. Flo's family was always supportive of her BPW activities. Her brother Jim was a frequent traveler with her to National Conventions and was often seen assisting at her campaign parties.

Flo felt that "service to one's community is a privilege rather than an obligation." Starting in 1967, she served in many capacities at North Bethesda United Methodist Church. For over 10 years, she was the Church Membership Secretary. Under her leadership, as Chairman of the Staff Parish Committee, she approved the pastoral appointment of the first woman minister in the history of NBUMC. Her other community activities included: Order of the Eastern Star; Wildwood Citizens Association (representative to the Bethesda Fire Department); Red Cross Volunteer; and Night Chairman of National Institutes of Health Red Cross Volunteers. She was also a member of the Montgomery County Citizens Alumni Academy Association; a member of The National Association of Parliamentarians; and the American Institute of Parliamentarians.

Flo's hobbies included: World War II history, genealogy, protocol and parliamentary law. She was a Certified Parliamentarian. Flo was a dog lover and had a pet for most of her life.

ZOOM INSTRUCTIONS 2020 BPW/MD ANNUAL CONFERENCE SEPTEMBER 12, 2020

We are excited to offer members and guests an opportunity to participate *virtually via ZOOM* in the **BPW/MD's Women's Leadership Conference and Suffrage Celebration on Saturday, September 12, 2020.** You do not need a Zoom account to participate.

Members and guests are required to pre-register for the conference, either with the Registration Form or online at our website <u>www.bpwmaryland.org</u>.

Once your Registration has been received, a Zoom link will be sent to all registrants in advance. You will click on the link for the conference, and it will allow you to enter the conference. Click on "Join with Computer Audio."

If you have never used Zoom before, it will take approximately 30 seconds for the application to upload to your computer, and you will be able to join the meeting. We ask that you enter the meeting any time after 8:30 a.m. so that you are connected in time to begin the meeting at 9:00 a.m.

Basic Controls for Zoom -You will see a tool bar across the bottom of the screen like this one.



Please note, we will be using "webinar" mode, which is slightly different than the "meeting" mode you may be familiar with (you will have less to worry about!)

- Audio/Video settings you will be automatically muted on entry. There will be opportunities throughout the sessions for you to raise your hand and the host will unmute and/or share your video.
- **Chat** this is the best way for attendees to communicate and share with each other throughout the conference. Simply type your message in chat and select the drop down "all panelists and attendees" and your message will be shared with everyone!



- **Q&A** throughout the event you will have the opportunity to ask questions or make comments. There are two ways to do this:
 - Type your question by clicking the Q&A icon on the bottom of the screen
 - <u>Raise your hand</u> to ask your question via audio.
- Screenview and settings in the top right corner of your screen you can toggle between Speaker and Gallery view to find your preference. In addition, if you click on the various boxes (chat, Q&A, etc) you can minimize and maximize views.

Tips for a better view using

- Set your laptop or computer so that the camera is at your eye level. (Too much ceiling or neck are not desirable!) Use books or a PC stand to elevate your PC.
- 2. Make sure your face is lit from the front and sides. An overhead light is usually too dark.
- Unless you add a virtual background (available to anyone who purchases a Zoom subscription), everyone can see what is behind you.

We are fortunate to have **Steve Gurney, founder** of **Positive Aging Sourcebook**, facilitating our Zoom conference this year. Steve will manage the participants' entry into the meeting (based on the registration list provided by Registration Chair Alicia Hannon) as well as manage screen sharing for speakers and all of the conference documents. Steve will also manage the breaks as well as the election, raffles and prizes, and an evaluation at the conclusion.

If you are new to Zoom and would like assistance, please contact **Susan Horst** (susanhorst@yahoo.com) for a practice session in advance. Any person with a PC with camera, or smart phone, will be able to attend via Zoom. If you do not have a PC with a camera, you may purchase a web cam that can be attached to your PC. You also have the option of participating by telephone, and telephone numbers with meeting ID and passcode will be provided to you.

Google "Zoom" on the Internet and take a basic tutorial – this will help you get comfortable with the application. Zoom offers a free subscription; sign up for it and open an account. It will offer you a 40-minute free Zoom meeting for starters.
